EU funding in a nutshell

EU funding phase 2021-2027: 1825 billion €

European Structure and Investment Funds (ESIF)

cca 70% of total funds available

- Funds for the implementation of the Cohesion policy \rightarrow to support less developed regions
- Shared management of funds between the EC and national authorities in EU countries
- National, regional and local administrations in EU countries choose which projects to finance and are responsible for their day-to-day management \rightarrow application at national level
- Large scale national / regional projects
- Allow large investments

Action Programs (AP)

- Funds to support the EU's common interests
- Directly managed funds by the EC
- Sector-specific programs (research, education, environment, etc.)
- Calls for proposals \rightarrow "individual" applications (consortia) \rightarrow EC evaluates proposals, signs grant agreement , makes payments, etc.
- All calls are available on the <u>funding and</u> <u>tenders portal (SEDIA)</u>.
- Smaller-scale international projects
- No investments, mostly reseach, collaboration







ESIF - Cohesion Fund (48,3 billion €)

Funding priorities: greener, low-carbon and resilient Europe,

supporting infrastructure projects (mainly transport and energy projects with clear environmental benefits, e.g renewables, energy efficiency)












ESIF – European Regional Development Fund (274,3 billion €)

Interreg A: cross-border cooperation (CBC)

cooperation between NUTS III regions from at least two different Member States lying directly on land, or maritime borders, to tackle common challenges identified jointly in the border regions (e.g. HR-HU, HR-SI)

Enhance the institutional capacity of public authorities, administrative cooperation and cooperation between citizens and institutions, etc. No investments

Interreg B: Transnational cooperation

Territoral coopeartion Enhance institutional capacity of public authorities and stakeholders to implement macro-regional strategies, no investments





In the EU, polluters have to pay for their greenhouse gas emissions via the Emissions Trading System (ETS). The money raised via the ETS is reinvested into the Innovation Fund: funding programmes for innovative low-carbon technologies.



Through the Facility, the Commission raises funds by issuing bonds on behalf of the EU, which are then available to MS to implement reforms and investments that target e.g. green transition











RRF funded projects in Croatia



Key measures for the green transition

- The plan supports the green transition through investment of €789 million in energy efficiency and post-earthquake reconstruction of buildings
- €728million will be invested in sustainable mobility, notably in upgrading railway lines, autonomous electric taxis with supporting infrastructure adapted for people with disabilities, installing charging stations for electric vehicles and introducing zero-emission vehicles and vessels.
- The plan allocates €658 million to low-carbon energy transition through modernising energy infrastructure, supporting investments for the production of advanced biofuels and renewable hydrogen and financing innovative carbon capture and storage projects.
- €542 million will be invested in supporting businesses for green transition and energy efficiency, supporting their projects aimed at boosting the green economy, sustainable tourism and investing in green technologies.


